## International Conference «Freight traffic on Dnipro River» May 16, 2016, Premier Palace Hotel, Kyiv, Ukraine

### Subjects to be highlighted:

- **Economy of river transportation.** Is it possible to reduce transportation costs in terms of river dues, pilotage, lockage and bridge opening?
- **Fleet.** What is the market trend – an order of newbuildings or a free call of foreign vessels?
- **Cargoes.** Competitiveness of river logistics for cargo owners.
- **Transportation.** Export, import or transit: what should transport companies be staking on?
- **Infrastructure.** Whether the handling capacities of river ports and terminals meet the requirements of cargo owners?
